- <sup>1</sup> This date is the last day that a sponsor can provide advance notification to target the expert committee meeting reported in that row of the table. Please note that sponsors are required to provide a minimum of 30 business days advance notice for anticipated submissions and resubmissions. All sponsors are encouraged to as much notice as possible prior to submission of files to facilitate resource planning (≥ 120 calendar days is preferred).
- <sup>2</sup> The date of receipt is considered day zero for the purpose of calculating the 10-business day targeted timeframe for the initial screening of the requirements. If the sponsor is targeting a specific meeting, they are encouraged to file the application early in the window to allow time for addressing any potential deficiencies.
- <sup>3</sup> Applications are typically initiated within 10 business days of being accepted for review.
- <sup>4</sup> For submissions that are filed on a pre-NOC basis, the draft recommendation will not be released until a copy of all required information has been received, including a copy of the NOC or NOC/c.
- <sup>5</sup> If there is no request for reconsideration filed by the sponsor and/or drug programs.
- <sup>6</sup> 2026 dates are subject to change.
