Target time does not include the time allocated for receipt of manufacturer's additional electronic copies (5 business days) and time allocated for distribution of electronic copies to reviewers (3 business days).

⁶ The target date for posting the CDEC final recommendation depends on several factors including the need for consultation with the manufacturer regarding redaction issues.
